



Terms of Service

Effective Date: January 20, 2026

By accessing or using the products and services provided by GreatData.com, Inc. ("GreatData," "we," "us," or "Licensor"), including data, datasets, analytics, or other intangible goods (collectively, the "Product" or "Products"), you ("you" or "User") agree to be bound by these Terms of Service ("TOS"), which constitute a legally binding agreement.

1. Acceptance of Terms

By accessing, using, or purchasing the Product, including by continued use after any updates to these TOS, you confirm that you have read, understood, and agreed to these TOS. You represent that you are at least 18 years old and have the legal authority to enter into these TOS.

2. Privacy and Personal Information

If you are not satisfied with the Product for any reason, you may request a **full refund within 30 days** of purchase. After a refund is issued, your rights to use the Product terminate immediately.

5. Disclaimers

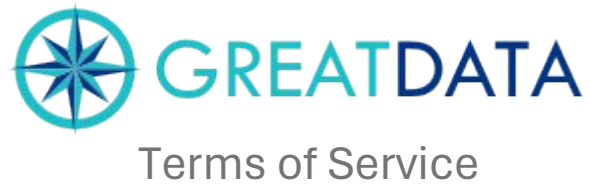

12. Governing Law

These Terms are governed by the laws of North Carolina, without regard to conflict-of-law rules. Any legal action not subject to arbitration must be brought in the state or federal courts located in North Carolina.

13. Arbitration and Waiver

Any dispute arising out of or relating to these Terms shall be resolved by binding arbitration under the AAA Commercial Arbitration Rules and the Federal Arbitration Act, in North Carolina. You waive any right to a jury trial and to participate in a class, collective, or representative action. This clause does not prevent seeking injunctive relief in court for intellectual property or other equitable claims.

14. Severability

If any provision of these TOS is found to be invalid or unenforceable, the remaining provisions shall remain in full force and effect.

15. Force Majeure

GreatData shall not be liable for any delay or failure to perform caused by events beyond its reasonable control, including acts of God, natural disasters, pandemics, war, terrorism, strikes, or internet outages.

16. Assignment / Transfer
